University PD gets certification

The University of New Haven's police department has become the first at a private college or university in the state to earn Tier I accreditation from the State of Connecticut Police Officer Standards and Training Council <<http://www.ct.gov/post/site/default.asp>>.

Only one-third of the police departments in Connecticut are accredited. The process is a long and hard one, but has its benefits.

"Accreditation reassures students, their families, faculty and staff of the high quality of the department," said Chief of Police Tracy Mooney, '08 M.S. "It is also important because our department needs to serve as a model for students at the University's distinguished Henry C. Lee College of Criminal Justice and Forensic Sciences."

The process to earn accreditation, which started in 2014, was led by Lindsey Michaels, who earned a bachelor's degree in criminal justice from the univer-

sity in 2015 and a master's degree in criminal investigations in 2017.

She worked under the direction of Mooney and Assistant Chief Don Parker, to write and update the department's entire catalogue of policies - a task typically delegated to a ranking officer within a police organization - all while achieving a 3.98 GPA.

"This was a tremendous undertaking," said Mooney. "Lindsey has become part of the police department family. She has the highest level of character and fully understands the demands and commitment of public service."

The accreditation review culminated this summer with an on-site visit completed by a team of independent assessors who compared the policies and practices of the university's police department to recognized standards of excellence in law enforcement services in Connecticut.

As part of the review, the department met 134 standards as determined by the Connecticut Police Officers Standards and Training Council.

Police departments seeking accreditation must demonstrate that they have comprehensive, well-thought out directives; provide managers with fact-based, informed management decisions; have a preparedness program to address natural or man-made critical incidents; and strive for an excellent relationship with the community and are accountable for their actions.

Accredited law enforcement agencies demonstrate excellence in management and service delivery," said Ron Quagliani, associate vice president of public safety and administrative services. "This accomplishment is a testament to Chief Mooney and all of our dedicated officers who work tirelessly to keep our campus community safe."

Insurance carriers Cigna and United Healthcare are not participating. Residents should bring all insurance cards and wear a short-sleeved shirt.

City collects recyclable electronics on Sept. 30

The Legislative Matters Committee of the West Haven City Council will hold a Public Hearing on an Ordinance Amending Chapter 150 BOTTLE CLUBS AND BYOB CLUBS on Monday, September 25th, at 6:50 P.M. in the City Council Chambers (3rd Floor City Hall, West Haven).

AN ORDINANCE AMENDING CHAPTER 150 OF THE CODE OF THE CITY OF WEST HAVEN, NIGHT CLUBS, BY THE ADOPTION OF ARTICLE II OF CHAPTER 150, BOTTLE CLUBS AND BYOB CLUBS

BE IT ORDAINED by the City Council of the City of West Haven that Chapter 150 of the Code of the City of West Haven, Nightclubs, is hereby amended by the adoption of Article II of Chapter 150, Bottle Clubs and BYOB Clubs which shall read as follows:

ARTICLE II
BOTTLE CLUBS and BYOB CLUBS

Sec. 150-3 Definitions.

Sec. 150-3.1 As used in this ordinance, BOTTLE CLUB means any establishment operated for profit or pecuniary gain which is not licensed by the Connecticut Department of Consumer Protection and admits patrons upon payment of a fee, cover charge or membership fee and in which alcohol, alcoholic liquors, alcoholic beverages, spirits wine or beer are not legally sold but where alcohol, alcoholic liquors, alcoholic beverages, spirits wine or beer are either provided by the operator or agents or employees of the operator for consumption on the premises or are brought into or kept at the establishment by the patrons or persons assembling there for use or consumption. The term shall not include a licensee under the Liquor Control Act.

Sec. 150.3.2 As used in this ordinance, BYOB CLUB means any facility operated for profit or pecuniary gain which is not licensed by the Connecticut Department of Consumer Protection wherein patrons may consumer alcohol, alcoholic liquors, alcoholic beverages, spirits, wine or beer which said patrons have carried or brought into the premises. The term shall not include a licensee under the Liquor Control Act or any facility which is rented for a limited period of time, not to exceed ten (10) hours, by an individual or

organization for the purpose of a private party.

Sec. 150-.3. As used in this ordinance, ALCOHOL, ALCOHOLIC LIQUORS ALCOHOLIC BEVERAGES, SPIRITS, WINE and BEER shall be defined as set forth in the Liquor Control Act, Sec. 30-1, et seq. Connecticut General Statutes.

Sec. 150-4 Regulations on Operation.

Sec. 150-4.1 It shall be unlawful and a violation of this ordinance for any person(s), corporation, partnership, firm or other entity to own, operate, lease, manage or control a Bottle Club or a BYOB club without having first obtained a valid permit issued by the West Haven Police Department.

Sec. 150-4.2 It shall be unlawful and a violation of this ordinance for any person(s), corporation, partnership firm or other entity to own operate, lease, manage, or control a Bottle Club or a BYOB Club without maintaining in force and effect at all times broad form general liability

insurance coverage with limits of one million dollars (\$1,000,000.00) per occurrence, proof of such coverage shall be submitted with the initial application for a permit or any renewal.

Sec. 150-4.3 It shall be unlawful and a violation of this ordinance for any person(s), corporation, partnership firm or other entity owning, operating, leasing, managing or controlling a Bottle Club or BYOB Club to allow entry thereto by or allow provision to or consumption by persons under the age of 21 years of any alcohol, alcoholic liquors, alcoholic beverages, spirits, wine or beer.

Sec. 150-4.4 It shall be unlawful and a violation of this ordinance for any person(s), corporation, partnership firm or other entity owning, operating, leasing, managing or controlling a Bottle Club or BYOB Club to be open for business or transact business between the hours 2:00 am and 8:00 am prevailing time of each day, and/or before Noon (12:00 pm) on Sundays.

Sec. 150-5 Enforcement. The West Haven Police Department is hereby authorized and directed to enforce the terms of this ordinance.

Sec. 150-6 Penalties for Violation
Any person or entity committing any act(s) prohibited herein shall be in violation of this ordinance. The ordinance shall be enforced pursuant to the provisions of Chapter 128 of the Code of the City of West Haven governing the local enforcement of ordinances. An administrative fine of Five Hundred (\$500.00) is prescribed and shall be paid for any violation of this ordinance. In addition, the City of West Haven may bring a civil action in the Judicial District having jurisdiction to enjoin the operation of any Bottle Club or BYOB Club operating in violation of this ordinance. In any civil action, a person or entity found to have violated this ordinance shall also be obligated within the judgment to pay all costs and attorney's fees incurred by the City in the enforcement action. Each day a violation of the ordinance continues shall constitute a separate offense. Each violation of this ordinance shall constitute a separate offence, subject to the prescribed fine for each violation.

Sec. 150-7 Fee(s)

Sec. 150.7.1 Applications for a Bottle Club or BYOB Club Permit shall be submitted to the West Haven Police Department along with a fee of \$200.00. An additional fee of \$200.00 shall be paid at the time of issuance of the permit. All payments shall be made by check or money order made payable to "City of West Haven."

Sec. 150.8 Permit Requirements

Sec. 150-8.1 Each Bottle Club or BYOB Club permit shall be good for a period of one (1) year and must be renewed annually. It must be displayed inside the premises so as to be visible to the public.

Sec. 150.8-2 To apply for a Bottle Club or BYOB Club permit the following items are required:
A government issued photo identification of the applicant or responsible party;

A request for a Bottle Club permit or a BYOB Club permit, dated and signed, on business letterhead stationery, which states the following:
The name and twenty four hours per day contact

information for the responsible party or parties for the applicant's business.

The operating name or names of applicant's business and the hours of operation.

The name of the landlord or property owner of applicant's business location and their contact information.

Please note that if any of this information changes a revised letter must be filed with the West Haven Police Department.

3) A photocopy of applicant's valid State of Connecticut and City of West Haven Food Facilities License with a classification of three or four.

4) Proof of insurance coverage as required in Sec. 150-4.2 of this ordinance.

Sec. 150.9 Grandfathering

This ordinance applies to any and all existing Bottle Club or BYOB Club establishments in the City of West Haven which shall upon adoption of this ordinance be fully bound by all provisions and regulations contained herein. All permits required by this ordinance shall be obtained by any and all existing Bottle Club or BYOB Club establishments in the City of West Haven within 30 days of the adaption of this ordinance.

Sec. 150.10 Revocation of Permit

Sec. 150-10.1 In the event that a Bottle Club or BYOB Club fails to fully and completely comply with the provisions of this ordinance or is found guilty of any unlawful activities or defined in this article during the term of its permit, the West Haven Police Department shall have the authority to revoke the Bottle Club or BYOB Club permit for a period of six (6) months.

Sec. 150-10.2 Permit and revocation decisions shall be made by the Chief of Police or his/her designee. Any person aggrieved by such decision may appeal to a court of competent jurisdiction within thirty (30) days of the receipt of notice of such decision. The City shall, upon filing such appeal, consent to any request by a permit applicant or person whose permit has been revoked for expedited review of such appeal. The City shall certify any records to the court within twenty (20) days of any request by the court to do so.

Sec. 150.11 Summary Closure

Sec. 150-11.1 Nothing in this ordinance prohibits the City of West Haven from taking any emergency action for the summary closure of any property which hold a permit under this ordinance when it is necessary to avoid an immediate threat to public welfare and safety.

Sec. 150.12 Severability

Sec. 150-12.1 If any section, subsection, sentence, clause, phrase or portion of this ordinance or its application to any person, property or circumstances is for any reason held invalid or unconstitutional by any court, such holding shall not be construed to affect the validity of any of the remaining provisions of this ordinance or its distinct and independent provision from the remaining provisions which shall be an remain in full force and effect. It is declared that the legislative intent of this ordinance would have been adopted had such invalid or unconstitutional provision of its application had not been included herein.

# A funny thing happened -- nobody died from words!

A funny thing happened when conservative pundit, author and intellectual Ben Shapiro spoke at the University of California at Berkeley last week. No one died, no one was injured and no one was maimed because of what he had to say. Granted, Berkeley police and the university took special precautions to keep the ironically named "anti-fascists" from pummeling those who would attend such an event, but those liberals and radicals who attended the lecture found out that words, in fact, don't kill.

It is a statement of faith by those who espouse the new radical progressive agenda that words are just as dangerous as actions. It is believed that safe spaces and trigger warnings are needed because the beliefs of others -- termed "fascists" -- are the same as violence and when they are said aloud, must be met with violence. Thus, so-called anti-fascists have in various parts of the country used violence against those with whom they disagree. I

That, ladies and gentlemen, is the essence of fascism. Irony, however, is not the strong suit of these individuals.

Funded by groups like the American Communist Party, George Soros' affiliated organizations and anarchists' groups, these young and 30-something radicals have fed at the trough of modern education which has delegitimized America for more than 40 years. The anti-war, anti-establishment hippies of the 60s have become the professors and educational leaders of today. They have not grown up, they have not changed their ideological views. They still live in a bubble that refuses to see good and evil, right and wrong and objective reality.

In recent weeks we have seen the tearing down of Confederate Civil War statues, the covering up of a musket on a cornerstone at Yale, the vandalism of a statue to Francis Scott Key, who wrote the "Star-Spangled Banner," and the rejection of the Founding Fathers because they were men of their time.

It is very easy to condemn with the faux mores of the day those who lived in a different time. It is easy to say America is illegitimate because it retained slavery rather than abolish it. But to the Founding Fathers establishing the nation was important and the controversy over slavery, which many founders wanted abolished had to be put aside. This is dealing with reality -- the reality of the time. Faced with founding a nation and figuring out its other problems later, the founders opted to tackle the subject at a later date.

The Constitution abolished slave trade soon after, and the 3/5 compromise, only counting 60 percent of the slave population was as much an effort by the north to retain the balance of power in Congress than an attempt to see slaves as only partially a person. The north wanted the end of slavery and subsequent events with compromises, both of 1820 and 1850 only prolonged the problem.

It took a nation based on Judeo-Christian values and history many decades and a war that killed more than 600,000 to settle the question. Meanwhile, slavery continued throughout the world, and does to this day.

Last week's speech by Shapiro proved the entire Antifa credo to be nothing more than an attempt to close debate and create division.

Much like the pro-slavery rioters of another era, they are using violence to end discussion. Much like the fascists of Spain, Italy and Germany, they use clubs and sticks to silence their opponents.

Words don't kill. Ideas like Antifa's, however, have killed millions throughout history.



# Turn off the TV, Mr. Trump!

Donald Trump is the first president in U.S. history to have been baited into undermining his own negotiating position by negative TV coverage.

Less than 12 hours after Attorney General Jeff Sessions explained that the administration is ending DACA -- Deferred Action for Childhood Arrivals -- because it's unconstitutional, Trump tweeted that he might revive the program if Congress doesn't act.

This was an implicit admission that he's bluffing on DACA, which gives Democrats every incentive not to trade anything meaningful for a codification of the program. Why make any painful concessions to save DACA if the president is loath to truly terminate it?

Surely, Trump wasn't thinking of any strategic or legislative imperatives; he was thinking only of how to push back against commentators calling him heartless. The time of the tweet -- 8:38 p.m. -- suggests that he was watching TV, and reporting has confirmed as much.

Which raises the questions: Doesn't the president have better things to do than watch political punditry on cable TV shows? As one of the most famous and powerful people on the planet, why does he care what pundits say about him? And doesn't he realize that his immigration agenda will get attacked by most commentators no matter what?

President Barack Obama famously described himself

as having a pen and a phone (that's how we got DACA). Trump has a phone and a remote control, and often works them in tandem as he criticizes, praises and comments on things said about him on air.

Trump is the most unusual combination of a politician who, on the one hand, was elected president by thumbing his nose at media elites and, on the other, is obsessed about what media elites write and say about him.

Trump is experiencing the agony of the media-bashing media figure. He follows what's said on cable TV more closely than many people who make a living as commentators on cable TV. He sometimes knows more about the industry gossip than people who work in the industry.

This reflects his background

as a TV star who leveraged his fame into the presidency. But it is, needless to say, highly unusual.

George W. Bush didn't pay much attention to his press coverage, confident that history would get it right and unwilling to get diverted from doing more important things. Barack Obama had an Olympian disregard for political punditry (as for many things). There are a couple of ways out of the dilemma. Trump can abandon his program and perhaps get some praise for "growing in office" (while destroying his presidency). He can continue, agitated by the coverage, to lash out, sometimes self-defeatingly. Or he can turn off the TV.

The right answer is "Click!" but he's as unlikely to give up the remote as he is his phone.

# Summer program taught life lessons

The Summer Youth Employment Program (SYEP), which is designed for families with low incomes, has existed for 40-plus years.

It is funded by the State of CT and distributed to the towns and cities in New Haven County through the Work Force Alliance Office in New Haven.

Young students from Bailey Middle School, West Haven High School, Notre Dame, Platt Tech and others who attend school outside of West Haven but reside in the city apply for these summer jobs. The SYEP hires these students to work four weeks of the summer -- five days a week four hours a day at the minimum wage of \$10.10 an hour.

They are placed by the SYEP staff at various jobs sites in different areas of West Haven, as close to where they live as possible.

The beach crew cleans the city beach parking lots, Sandy Hook Playground, Bradley Point, Old Grove at Savin Rock, the area around the Conference Center and Savin Rock Museum, along with the many piers and the boardwalk.

On their first day this summer, they swept the piles of sand that had accumulated on the ramps going down to the piers. A resident from Surfside Senior Housing came down to the ramp and could not thank them enough for sweeping the sand away. He is now able to take his wheelchair and go out on the pier and enjoy the view. The students walked every day with a five-gallon pail to put their trash in on their way to the different sites that needed cleaning. These young people take great pride in the work that they do each day. They receive many compliments from the residents.

You can recognize them by the shirts they wear, which has the West Haven SYEP logo on them. Their supervisor started out in the program himself on the beach crew years ago and could not be happier to share his expertise and experiences with the students.

The SYEP has workers in the Allingtown and Johnson-Noble Senior Center. They work with young children and senior clients as aids. Some of their duties include serving lunch and doing maintenance work. One of the student workers assists the head maintenance person at the West Haven Community House.

Some students work out of the West Haven Housing Authority in the different Senior Housing buildings doing general maintenance. There are two girls who work in the main office of the Housing Authority and the Section 8 office on Glade Street. Others

work as camp counselors at the Glade Street park camp. The VA Hospital provides summer jobs to many students that complete various tasks, including volunteering in the service office, food service and the supply room. They are provided with their own t-shirts and 10 badges, so the clients know they are there to help in any way they can. There are two supervisors, who also were former SYEP workers, which work at the VA and the Noble Senior Center. There are workers in City Hall, whose responsibilities include filing and answering phones.

The Center District Fire House on Elm Street has a student who does general maintenance.

There are also students that work in the school system, helping the custodians to get the schools ready for the new school year.

Those that worked in the Food Service Department in the past years assisted in preparing meals for the Park-Rec camps and the various drop off sites, where young children can receive a lunch each day. The SYEP also provides workers to some private sectors, such as Vio's Sporting Goods.

The student was able to assist with the printing of t-shirts and uniforms, as well as other jobs. He has excellent computer skills, which were used in helping to set up new programs for the store. Another location, Aqua & Physical Therapy Sports Complex (Quest) on Campbell Avenue, had students whose duties included filing and cleaning and wiping down of the equipment after the clients were done using it. They also made phone calls to the clients to remind them of their appointments.

This past summer, there was no funding available for the Summer Youth Program, not only in West Haven, but throughout the State of Connecticut. We almost did not have a program because there wasn't a budget in place by the State Legislators.

The Summer Youth office staff spoke with the mayor's office and the Finance Department to see what they could do to help us have a program. The outcome was exciting.

July 13, the University of New Haven announced it will partner with the city to fund the city's summer Youth Program. The university will contribute \$25,000 and the contribution will be matched with city funds.

The program is typically

funded fully by the state. However, this year, because the state had not adopted a budget, no funding for the program was available. With the \$50,000 we could hire 53 young people and we thank them for that.

Last year, we had a budget of \$104,000, which was provided fully by the state. This enabled

us to hire 126 young workers. We could not rehire some of these workers due to the monetary constraints.

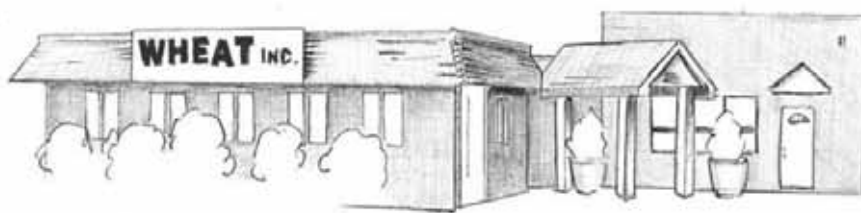
This program not only gives the students the opportunity to get a great learning experience in the workplace, and able to earn money for themselves. It gives them a chance to get involved in their com-

## University moves up in US News ranking

The University of New Haven announced today it has been ranked, once again, among the best in the U.S. News & World Report college rankings.

The University moved up in the rankings of regional colleges in the north this year. It was also ranked in the top 50 nationally for both overall value and value for veterans.

The Tagliatela College of Engineering is ranked among the top 100 best engineering programs in the nation.

The news comes just after The Princeton Review -- for the second year in a row -- chose the University as one of the nation's best institutions for undergraduate education.

The Princeton Review does not rank colleges but includes only 15 percent of America's 2,500 four-year colleges in its "The Best 381 Colleges" guidebook..

The rise in the rankings is one reason the University is attracting students from around the globe. This year, the University of New Haven's first-year class was the largest in University history with a 33 percent increase over last year. The class includes students from 33 states and 21 countries.

# Historian's corner By Dan Shlne

## Edgar C. Stiles School Part II

While Edgar Stiles was a devoted educator, he was also very civic-minded. In 1906, he joined the fledgling West Haven Village Improvement Association; this group saw as their mission: town beautification, a shade tree planting program, encouragement of lawns and gardens, and establishment of parks (including Bayview and Shingle Hill parks, on either end of Main Street). There was one other plan that they developed: that there should be an established public library serving West Haven. Stiles took an active role in all of this.

In addition, Stiles was a tireless servant of First Congregational Church. That church was his place of worship, and over the years, he served faithfully on various boards and committees there.

In 1907, Stiles was one of 60 people who established the New Haven Bird Club; immediately, he was elected as its president, and remained in that capacity until 1925. It is interesting to note that quite a few West Haven educators of that day were part of the club during that period: Edith E.

Mackrille, Anna V. Molloy, and Alma E. Pagels are names that are recognized by most West Haveners. In addition, there were quite a few teachers: Mabel B. Casner (Washington School), Marjorie Brett (multiple schools including Stiles and Haley School), Helen Hart (Washington School), and Martha L. Sandmeyer (Washington School).

Edgar Stiles remained a bachelor until he was 45 years old. At some point, he began courting an English teacher, Edna L. Morgan, who was originally from Enfield, NH. Each year, they would retreat to her hometown to spend the summer. It was on one of these trips that Edna became ill and passed away in 1932. She was buried there in the family plot.

After Edna's passing, Edgar Stiles returned to West Haven and the task of managing West Haven's schools; there were now four times as many schools as when he started as superintendent. One of the new schools was Edgar C. Stiles School, noteworthy in the fact that it was built and dedicated to him while he was alive and still working as school superintendent.

Edgar Stiles was at his

New Hampshire summer home when he became ill in 1933. He was rushed back to New Haven and admitted to New Haven Hospital, where they performed two surgical procedures on him. At first his condition seemed to be

improving, but then he took a turn, and passed away on Aug. 29, 1933. What followed was one of the largest funerals in West Haven history, as the high and the humble turned out to pay their last respects to a true pillar of the community.

Stiles was buried beside his beloved Edna, in the family plot in Enfield, New Hampshire's Oak Grove Cemetery.

**Dear Nervous Motorist:**

Gripe Vine received similar complaints from motorists who were "shaken up" when encountered with this activity. Good news! West Haven has passed an ordinance prohibiting the reckless and dangerous operations of bicycles.

According to the ordinance, "No person shall operate a bicycle without the regard for the safety and rights of pedestrians and drivers and occupants of other vehicles as to endanger the life, limb, or property of any person while in the lawful use of streets or sidewalks of any public or private property without exercising reasonable and ordinary control over such bicycles by trick riding, or weaving, or zigzag course unless such irregular course is necessary for safe operation in compliance with the law."

If a minor under the age of 18 violates the new law, according to the ordinance, West Haven Police <http://wtnh.m/?s=west+westhaven+police>, reserve the right to impound the bicycle. Plus there will be a \$25 charge per day for each impounded bicycle. Now, if the bike isn't claimed after 30 days, it will become the property of the City of West Haven.

The penalty for violating this ordinance will be a fee of \$100.

# Westies top Governors, 47-20

The West Haven football team traveled to New Haven on Friday afternoon to face the Wilbur Cross Governors and were looking to get its running game on track. The Blue Devils did just that with the tandem of Kyle Godfrey and Chris Chance piling up 331 yards rushing and scoring six touchdowns in a 47-20 victory to improve their record to 2-0.

On the first drive of the game, the Westies marched 56 yards and capped the drive with a Chris Chance 3-yard TD run. The Westies missed the extra point and led 6-0. The Governors wasted little time on their first possession when they scored on an 80-yard touchdown run on the first play from scrimmage. Cross would add the extra point and hold its only lead of the day at 7-6.

The Blue Devils came right back when Godfrey finished off a 62-yard drive with a 1-yard touchdown plunge to put the Westies up 14-7 after a Zach Conlan two-point conversion. The Governors would tie things up with 1:06 left in the half on a 5-yard touchdown pass and it looked like the teams would be heading into halftime knotted at 14-14. The Westies had other plans though. With West Haven positioned at midfield, Jake Conlan pitched the ball to Chris Chance, who fired a pass to Jordan Wetmore

streaking down the left sideline. Wetmore caught the ball in stride and raced for the end zone before being caught at the 2-yardline. Zach Conlan would force his way into the end zone on the next play and the Westies took a 21-14 lead with 4.3 seconds left in the half.

In the second half, the Westies took control when Kyle Godfrey raced 43 yards just 2:29 into the third quarter to increase their lead to 28-14. Chris Chance would score on a 2-yard run with 3:20 left and on a 57-yard TD run with 17.5 seconds left in the quarter to make it 41-14. Cross finally got on the board again with a 40-yard TD pass 1:05 into the fourth quarter. But the Blue Devils put an end to any Governor comeback hopes with a Godfrey 28-yard TD scamper to make it a 47-20 final.

Chris Chance finished with 201 yards rushing and three touchdowns while Kyle Godfrey picked up three touchdowns on 130 yards on the ground. This week, the Westies open up their home schedule hosting cross-town rival Notre Dame of West Haven in the annual Soderman Bowl at Ken Strong Stadium at 7.

The boys soccer team traveled to Shelton for an afternoon clash on the pitch against the Gaels on Saturday. Things didn't start off well for the Westies when the Gaels took

a 2-0 first half lead. The Blue Devils stepped it up in the second half and got one back on a corner kick by Matt Frend that was headed in by Al Alfazzani with 23:23 left in the game to cut the lead to 2-1. Five minutes later, the continued West Haven pressure forced a penalty in the box and Matt French converted the penalty kick to knot the game at 2-2 with 18:23 left.

The Gaels seemed to kick it into another gear and poured the pressure on the Westies. A huge save by Saul Novoa

with 10:44 left and another at 7:58 kept the scored tied. But, the Westies were whistled for a penalty in the box with 4:50 left and the Gaels took advantage on the PK for a 3-2 lead. West Haven tried to crack the Shelton defense but were unsuccessful the rest of the way. Novoa finished with ten saves in between the pipes for the Blue Devils.

The boys hosted Sheehan on Monday, Fairfield Prep on Wednesday and finish the week with a trip to North Haven on Friday at 7 against the

Indians.

The girls' soccer team hosted the Cross Governors on Tuesday evening at Ken Strong Stadium and jumped all over the Governors with four, first half goals on its way to a 4-0 victory. Kelsey Gilmore got her second goal of the season just 4:02 into the game and McKenzie Holy ripped a shot 1:14 later from 28 yards out over the leaping Cross goalkeeper for a 2-0 lead. Keegan Riccio converted a beautiful, crossing pass from Selana Izzo

## WestieBlue in touch

West Haven running backs Kyle Godfrey and Chris Chance never got going offensively in the season opener against North Haven last week. It took both less than a quarter to show how dynamic they can be.

Combining for six touchdowns and 331 yards on the ground, Chance and Godfrey

led the Westies to a 47-20 victory over Wilbur Cross in a Southern Connecticut Conference contest at Barbarito/Marone Field at the Wilbur Cross Athletic Complex in New Haven Friday afternoon.

"We had some very good practices this week," Chance said after rushing for 201 yards and three touchdowns.

"We did not feel out offense was good last week. We had to make a statement today."

With the game a one-score contest entering the third quarter, West Haven pulled away with a dominant third quarter, outgaining the Governors 179-20, and scoring three times in the process.

Godfrey gave the Westies a 28-14 lead when he scampered in from 43 yards out just 2 minutes, 29 seconds into the second half. Chance scored the next two touchdowns, from two yards out on fourth down, and his third of the day from 57 yards away for a 41-14 advantage with 17 seconds remaining in the third quarter.

"Obviously, we ran better than last week," West Haven coach Rich Boshea said. "Last week, our offense did not do what it wanted to do. We have to continue to work to get better offensively. Cross is a good team. They have some great players. We played well."

The first half saw 308 total yards of offense, with the Westies using a late score to take a 21-14 advantage. West Haven finished with a 466-201 advantage in yards in the game.

The game was even at 14 after Sal Barnabei hit Kwane Taylor with a 5-yard scoring

pass with 1:06 to go in the half for the Governors. Cross, which used 16 plays and took 8:08 off the clock on the drive, looked as if it would go to the half on a high note.

Instead, West Haven (2-0), which had run just three offensive plays in the second quarter to that point, needed just four more to take the lead with four seconds to go in the second quarter.

The big play came with eight seconds to go as Chance hit Jordan Wetmore in stride for a 49-yard halfback option pass to the Cross 1-yard line. Zach Conlan ran in on the next play to put the Westies ahead at the half.

"That was a momentum changer," Cross coach John Acquavita said. "We don't have the bodies to sustain playing both ways against a school like that. They are tough. Our guys didn't come off the field and they were able to wear us down. We were able to stay with them until the third quarter. After that, you can tell we were gassed."

The game had all the makings of a high-scoring affair as 21 points were scored just 6:20 into the game. West Haven, which had 185 yards of offense in the opening half,

opened the scoring five plays into the contest when Chance, (56 yards on the initial drive), scored from 3 yards out.

West Haven missed the extra point and Cross (1-1) took the lead on its first offensive play from scrimmage as Jasiah Barnes raced around the edge and scored from 80 yards out for a 7-6 Cross advantage.

The Westies responded 10 plays later to cap a 62-yard drive when Godfrey ran in from one yard out, then Conlan ran in the conversion for a 14-7 advantage. The Westies ran for 136 yards in the opening half, including 86 by Chance.

"That pass play before the half was huge," Boshea said. "Chris Chance made a great throw to Jordan Wetmore and he made a good catch. We needed a lift before the half and we were able to get it. After that, I think we were able to wear them down in the second half."

West Haven did a good job on Barnes, limiting him to just 27 yards on the ground after his long touchdown to start the game for the Governors. Barnes finished with 107 yards on 14 carries.

Barnabei passed for 127 yards and two scores in the loss for Wilbur Cross.

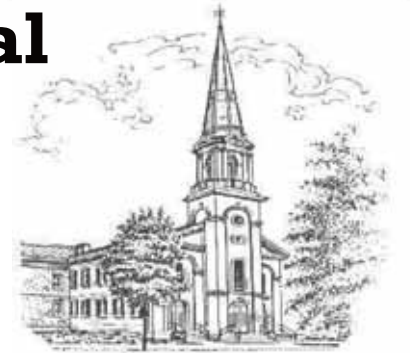

The Mighty Mite team (7-9 year olds) played four outstanding quarters of football. The Mighty Mite level is completely fundamental and no score is kept.

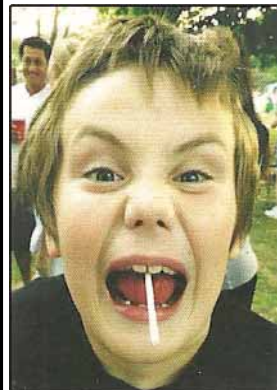


